**Active Dredge Charts**

Regional Active Dredge Area Charts - Issue 25 now available

Regional Active Dredge Area (RADA) charts are routinely produced by the British Marine Aggregate Producers Association (BMAPA) and The Crown Estate on a bi-annual basis (charts are dated 31st January and 31st July) to show where dredging operations are currently permitted within existing marine aggregate production licences.

Areas where dredging is permitted are monitored through the approved 'black box' Electronic Monitoring System (EMS) that is required to be installed on every marine aggregate dredger operating in UK waters.

Issue 25 of these charts (dated 31st January 2015) is now available to be downloaded from <a href="http://www.bmapa.org/issues/other\_sea\_users.php">http://www.bmapa.org/issues/other\_sea\_users.php</a>. The need for working areas within production licences can be defined through existing licence conditions or through individual marine aggregate operators' voluntary management arrangements.

Any changes in licence area or active zone from the previous issue (dated 31st July 2014) will be highlighted in red.

Marine Aggregate Survey Notification – Area 460 (English Channel)






