



Overfishing of pelagic stocks by Northeast Atlantic Coastal States in 2021




Northeast Atlantic mackerel



Overfishing and stock collapse – We've been there before with Northeast Atlantic cod, off Canada and the USA.


Now, Northeast Atlantic pelagic stocks are in danger of becoming drastically depleted, as Coastal States struggle to follow the science and agree long-term management plans.





The latest catch-limit advice for Northeast Atlantic pelagic stocks issued by the International Council for the Exploration of the Sea (ICES) show that fishing pressure is above sustainable levels and that further reductions are required, according to the North Atlantic Pelagic Advocacy Group (NAPA).

ICES advised the 2023 catch for Northeast Atlantic mackerel should be no more than 782,066 metric tons (MT); a 1.6 percent reduction from its 2022 advice. However, in

a statement released ahead of its annual coastal states meetings, NAPA said the agreed 2022 total allowable catch (TAC) was set at 1,131,416 MT. Therefore, to follow the ICES advice in 2023, a cut of 31 percent is required, it said.

Similarly, ICES advised 2023 catch for Atlanto-Scandian herring is no more than 531,171 MT; a 14.6 percent reduction from the 2022 advice. However, in 2022 there was no agreement on the TAC; the sum of the declared unilateral quotas from the individual parties was 627,963 MT. NAPA said that in order to follow ICES' advice next year, a cut of 38 percent is required.

The North Atlantic Pelagic Advocacy Group (NAPA) has joined forces with the Marine Stewardship Council (MSC) to urge "tangible action" on the sustainable management of Northeast Atlantic pelagic stocks.

The collaboration comes after a previous effort from NAPA to urge alignment with catch-limit advice from the International Council for the Exploration of the Sea (ICES). Ahead of the mid-October 2022 Coastal States meetings, and November's North East Atlantic Fisheries Commission (NEAFC) meeting, the two organizations have written an open letter to E.U. fisheries ministers requesting they rectify management flaws that they maintain are fueling overfishing in the Northeast Atlantic.

The letter claims overfishing has been taking place in the region since 2014, and that the consistent fishing effort above scientific advice "has the potential to throw this vital ecosystem out of balance," with knock-on impacts for the environment, fishers, consumers, and the supply chain.



MSC calls on coastal states to “act decisively” on Northeast Atlantic mackerel quotas

The Marine Stewardship Council (MSC) is calling on coastal states that harvest Northeast Atlantic mackerel to secure a long-term quota-sharing agreement as the deadline to make a decision approaches.

A number of fisheries in the North Atlantic have had their MSC certifications suspended due to coastal states in the region failing to set quotas low enough to align with scientific advice from the International Council for the Exploration of the Sea (ICES). North Atlantic mackerel was one of the species that lost MSC certification due to ongoing management issues.

ICES has recommended that for 2023, the catch of Northeast Atlantic mackerel should be no more than 182,066 metric tons (MT), a 1.6 percent reduction from 2022.

While the ICES recommendation has dropped 1.6 percent, coastal states were not in line with the recommendations in 2022. The North Atlantic Pelagic Advocacy Group (NAPA), a group of retailers established to push for coastal states to fix the issues with the fisheries in the region, pointed out that the total allowable catch for North Atlantic mackerel was set at 1,132,426 MT in 2022. That means coastal states need to agree to a 31 percent cut in quotas to align with current guidance.

Coastal states are meeting to secure a long-term quota-sharing agreement by 31 March, 2023 – and MSC is urging that the states meet the ICES recommendations. It is also calling for harvest control rules for the fishery, so that managers can ensure long-term sustainability for the stocks.

In the absence of this framework, nation-states have been able to set total allowable catches in line with their own national interests, rather than following internationally set limits defined by the International Council for the Exploration of the Sea, the MSC said.

This week the coastal states with interests in the North-East Atlantic's pelagic fisheries are meeting in London. The aim is supposed to be to reach agreement on the sustainable exploitation of mackerel, blue whiting and Atlanto-Scandian herring that migrate through both national and international waters.

This year's fisheries on these stocks are marked by agreement last year on the TAC levels – but a failure to agree how that TAC should be divided between the coastal states concerned. As a result, there has been something of a free-for-all, in which the UK's exit from the European Union is seen as a contributing factor as a new coastal state at the negotiating table has complicated matters even further than in the past.

Bad luck for the pelagic species of the Atlantic

The latest scientific advice for mackerel, herring and blue whiting in the northeast Atlantic is poor. The disagreement between the riparian countries risks worsening the situation.

The International Council for the Exploration of the Sea (Ciem) published on September 30 several notices on fisheries for pelagic species in the northeast Atlantic. It recommends, in particular, to set for 2022 a total authorized catch (TAC) of 794,920 tonnes for mackerel, a level down by 6.7% compared to the advice for 2021. For Atlanto-Scandian herring, the recommendation is 598,588 tonnes (-8%) and for blue whiting 752,736 tonnes (-19%) compared to the 2021 catch advice.

These declines for 2022 do not mean that stocks are doing poorly in the long term. Thus, for herring and blue whiting, the biomass is not yet in poor condition. But the old disagreement between the coastal states on the distribution of this resource, accentuated by Brexit, results in the TAC being exceeded in 2021 by 42% for mackerel, 39% for herring and 30% for blue whiting. This has already resulted in the suspension of several certifications by the Marine Stewardship Council (MSC).

This situation gave rise to the creation of a transnational pressure group, bringing together British, Nordic and European industrialists and distributors, the North Atlantic pelagic advocacy group (Napa). In a press release published even before the dissemination of Ciem's opinions, it asks fishing countries to "put aside their national interests and commit to adopting sustainable management measures for these stocks at the next meeting of States. coastal". This 40th annual meeting of the North East Atlantic Fisheries Commission (NEAFC NEAFC English) is scheduled from 9 to 12 November.

The Marine Conservation Society (MCS), a U.K.-based non-governmental organization, has become the latest organization to designate Northeast Atlantic mackerel an unsustainable choice after coastal states failed to meet a deadline on shares of the species.

Multiple organizations have called on coastal states harvesting Northeast Atlantic mackerel - which is fished by the E.U., U.K., Iceland, and Norway - to reach an agreement on the species aligning with scientific advice from the International Council for the Exploration of the Seas (ICES). The fishery was one of multiple pelagic species that lost Marine Stewardship Council certification after coastal

states failed to reach an agreement that kept total allowable catches in line with scientific advice.

The coastal states set a deadline of 31 March, 2023, for some form of agreement on sharing the Northeast Atlantic mackerel stock, but that date passed with no agreement.

The North Atlantic Pelagic Advisory Group (NAPA), a group of retailers established to push for improved regional fisheries management, said the countries involved in the fishery had "blown it."

"We had thought that [the problem with] Northeast Atlantic mackerel was being taken seriously by the coastal states, and their self imposed 'hard deadline' would stimulate agreement on catch shares," NAPA Project Lead Tom Pickereil said. "But

In December 2022, the Northeast Atlantic Coastal States announced they had set themselves a deadline, 31st March 2023, to reach an agreement on the sharing of Northeast Atlantic mackerel catch. As their own "hard deadline" passed, the negotiations ended in dismal failure with no agreement reached. What will it take for the Coastal States to work for the common good - and meet their own sustainability commitments?

There are serious problems in the Northeast Atlantic mackerel fishery - overfishing has been happening since 2005.

No concrete steps were taken to rectify the fundamental management flaws that are fueling this overfishing and in 2019 the Marine Stewardship Council (MSC) certification was suspended from the mackerel fisheries due to poor governance and inadequate management.

In the same year, the global marketplace for seafood realized that relying on the Northeast Atlantic Coastal States to put aside their own national interests and work collaboratively to agree sustainable catch shares and end overfishing was futile. Over the last decade, negotiations between the seven parties have routinely broken down, with them instead looking to maximize their individual shares.

The North Atlantic Pelagic Advocacy Group (NAPA) was established with a very simple, and focused, aim: to use market pressure to drive the Coastal States to put aside their politics and instead collaborate to ensure that catches do not exceed sustainable levels.



TOP LEVEL ASKS

- Agree sustainable catch shares**
The Coastal States should prioritise resolving the allocation issues around these stocks.
- Follow the scientific advice**
The Coastal States should ensure that the overall catch for each stock does not exceed the scientific advice.
- Commit to long-term management**
Multi-annual management should be the underlying approach by default.
- Cap on catching in international waters**
Further overfishing could be constrained by a cap on catches in international waters.

FIPS BACKGROUND

Rationale behind the FIPs

NAPA has developed two Fishery Improvement Projects (FIPs) in direct response to the suspension of Marine Stewardship Council (MSC) certification for mackerel, Atlanto-Scandian herring, and blue whiting fisheries in 2019 and 2020. Both tools use the framework of a traditional, science-based FIP as a guide for driving political action towards cooperative decision-making and sustainable management for key pelagic stocks.
