Introduction

This report contains key facts relating to the UK's seafood exports, including key countries and species.

- <u>Export summary</u> Seafood exports have increased value and volume, whilst experiencing inflation:
- <u>Top 20 destination countries</u> The countries that receive the largest value of seafood exports are France, USA and Spain.
- <u>Top 17 export species</u> The species with the greatest export value are salmon, nephrops and crabs.
- <u>Top 6 export species by country of origin</u> A breakdown of the top 20 export destination is provided for the top 6 species; salmon, nephrops, crab, mackerel, scallops, and cod.




Top 20 seafood export destinations from the UK by % share of total export value and volume
