




EU SOCIAL DIALOGUE COMMITTEE FOR SEA FISHERIES

- **All three organisations in the SSDC-F consist of representatives from EU MS**
- **All three parties have a mandate**
- **The SSDC-F holds 3 meetings per year**
- **For each year a working program is agreed between the organisations**
- **EU-funded projects to implement the working program**



EU SOCIAL DIALOGUE COMMITTEE FOR SEA FISHERIES

- **The SSDC-F can make agreements at Union level on a number of social areas, that the Union may transpose into Union legislation**
 - **The ILO Work in Fishing Convention, 2007 has been implemented in the entire EU through a social partners agreement between the parties in the SSDC-F**
- **Other initiatives involve joint**
 - **resolutions (e.g. on treatment of migrant fishers)**
 - **letters (on various subjects relating to the social aspects of sea fishing)**
 - **studies**



EU SOCIAL DIALOGUE COMMITTEE FOR SEA FISHERIES

Fishing capacity (gross tonnage and propulsion power)

Role of minimum standards – role of voluntary schemes



Joint Resolution on SEAFOOD SOCIAL STANDARDS and SUPPLY CHAINS

ILO C188 the main international 'guardian' of labour standards

Full inclusion of internationally agreed labour standards in private labels

Inclusion of social partners – in particular unions – in the process

Solid monitoring and enforcement mechanisms
