

North Atlantic Pelagic Advocacy (NAPA) Group

Terms of Reference

Role/Purpose

- 1. The North Atlantic Pelagic Advocacy Group (the 'Group') was created as a sector wide, multistakeholder initiative of partners to build a shared, global and non-competitive solution to sustainability issues in the North East Atlantic Pelagic fisheries complex.
- 2. The Group sets out to achieve an agreement on total allowable catches for North East Atlantic Pelagic fisheries in line with scientific advice, and for a long-term science-based management agreement.
- 3. The Group does not represent a 'collective buying' position for the members, and that policy decisions to buy or not buy materials originating from these fisheries remains entirely within the policy jurisdiction of the individual businesses.
- 4. It is the responsibility of Group and Subgroup members to ensure that they understand their responsibilities under all applicable competition laws, including EU competition law.

Term

5. This Terms of Reference is effective from June 2020 and will be ongoing until terminated by agreement between the parties.

Membership

- 6. Group members are an inclusive constituency of supply chain companies with a major interest in improving the sustainability of the North East Atlantic Pelagic fisheries complex, as well as a commitment to actively support the Group.
- 7. Voting members are fee-paying companies from food service, retailer, brand manufacturer, and supplier sectors active in the North East Atlantic Pelagic fisheries complex sector (excluding fishing/vessel organisations) that have been accepted by the Steering Committee.
- 8. Non-voting members are non-fee-paying companies from food service, retailer, brand manufacturer, and supplier sectors active in the North East Atlantic Pelagic fisheries complex sector (excluding fishing/vessel organisations) that have been accepted by the Steering Committee.
- 9. Observers are representatives from NGOs and trade federations that have been invited to participate in the Group by the Steering Committee. Observers are not entitled to vote.
- 10. The Group comprises representatives as listed in Annex 1

Roles and Responsibilities

- 11. The Group is accountable for:
 - a. Fostering collaboration
 - b. Maintaining at all times the focus of the Network on the agreed scope, outcomes and benefits
 - c. The members of the Group will commit to:
 - i. Attend all scheduled Group meetings and if necessary, nominate a proxy.
 - ii. Champion the Group within and outside of work areas.
 - iii. Share all relevant communications and information across all Group members
 - iv. Make timely decisions and take action so as to not hold up the project.
 - v. Notify members of the Group, as soon as practical, if any matter arises which may be deemed to affect the aims of the Group.
 - vi. Keep all information presented and discussed at the meeting confidential.
- 12. Members of the Group will expect:
 - a. That each member will be provided with complete, accurate and meaningful information in a timely manner
 - b. To be given reasonable time to make key decisions
 - c. To be alerted to potential risks and issues that could impact the aims of the Group, as they arise
 - d. Open and honest discussions, without resort to any misleading assertions.

Meetings

- 13. Meetings will be held as required and will be chaired by Aoife Martin, Seafish.
- 14. A meeting quorum will be a majority of funding members present.
- 15. Decisions will be made by consensus (i.e. members are satisfied with the decision even though it may not be their first choice). If not possible, the decision under discussion shall be put to a vote. Decisions will be made following a 75% majority and each member has one vote.
- 16. Meeting agendas minutes will be provided by the Secretariat, this includes:
 - a. Preparing agendas and supporting papers
 - b. Preparing meeting notes and information.
- 17. If required, subgroups will be established and subgroup meetings will be arranged outside of these times at a time convenient to subgroup members.

Steering Committee

- 18. The Group Steering Committee is an advisory body that will make decisions and/or provide guidance on the following matters; budget spend, contracts, NAPA policy and governance issues, engagement strategies, and project management concerns. The Steering Committee will also determine the Group membership.
- 19. The Steering Committee will consist of voting members and will be formed from representatives from each of the NAPA fee-paying parties. The Chair will also be a member of the Steering Committee.

20. Membership of the Steering Committee is detailed in Annex 2. Composition of the Steering Committee can be amended as required.

Amendment, Modification or Variation

- 21. This Terms of Reference may be amended, varied or modified in writing after consultation and agreement by Group members.
- 22. The Terms of Reference will be reviewed by the Steering Committee every 12 months.
