## Am I eligible?

Any experienced commercial fisherman (with at least 2 years' fishing experience), who has completed all of the required (mandatory) fishermen's basic safety training courses, is eligible to apply for this card.

## What use is it?

The credit-card sized, durable plastic card is accepted by the Maritime & Coastguard Agency (MCA) as proof that the holder has completed all of the basic safety training required by an experienced commercial fisherman.

## What does it cost?

The cost for production of this card is £10.00\*.

## How do I apply?

- 1) You must complete and sign the application form overleaf.
- 2) You must submit 1 passport-size photograph signed by you on the reverse. It must be attached either by staple or paper clip in the box at the top left-hand corner of the application form. Your photograph will be printed on your card.
- 3) You must provide the dates on which you completed the required courses. These will be checked and verified on our database. If you have lost or misplaced your certificates and can't remember when you completed the courses, please call us on the number below before returning this application form and we will help you.
- 4) If any of your courses were not Seafish courses (e.g., STCW or RYA), you must send us scanned copies of your certificates, so that we can check and verify them.
- 5) Send your completed form, with photograph and payment\* to the address below.
- 6) Your card will be posted to the address provided by you on your application form. Please allow up to 28 days for production and delivery.

\*You can pay over the phone with a debit/credit card by calling the Training Administrator (see number below). Alternatively you can pay by cheque or postal order made payable to Sea Fish Industry Authority. Please do not send cash.

- A 2 Day Engineering Course

#### **Unrestricted Ticket**

- A 2 Day Stability course Day 1 Stability Awareness for Experienced Fishermen & Day 2 Advanced Stability Awareness
- A 1 Day GMDSS Short Range
- A 5 Day Bridge Watch-Keeping Course (18 months service in the fishing industry is required before this course can be taken. A testimonial must be provided as evidence)
- A 5 Day Engineering Course (MCA 30 Hour Advanced Engine Course)
