#### **ASC's Work to Support Human Rights**



All ASC's 11 species-specific Standards and the Feed Standard contain criteria that work for the protection of the human rights of employees and those who live in communities surrounding the farms and feed mills.



The ASC Farm Standard, which will be released in 2024, further strengthens human rights protections.

#### **ASC** and other standards



We have carried out internal benchmarking against other standards, including the ETI base code (SMETA basis), SSCI production scope, SA8000, Amfori-BSCI Code of Conduct and BRCGS.



This internal benchmarking shows that ASC is notably stronger than other standards in several areas, and particularly in comparison to the ETI base code, has particular strengths in terms of grievance requirements and requirements around engagement with surrounding communities.

One piece of work which we have recently completed that may be useful to you is the ASC Country Score Card




The Score Card uses external databases to give a risk rating to every country, providing a feed mill with information about the social, legal and environmental risks of the countries where they source ingredients from.


