

## **NEW ENTRANT FISHERMEN PHOTO-ID CARD APPLICATION FORM**

(Please complete overleaf in BLOCK CAPITALS)

### **Am I eligible?**

All new entrant fishermen, who have completed the Seafish four one day safety courses are eligible for this certificate. All other certification will have to be verified by the Maritime and Coastguard Agency.

### **What use is it?**

The credit-card sized, durable plastic card is accepted by the Maritime & Coastguard Agency (MCA) as proof that the holder has completed all of the basic safety training required by a New Entrant commercial fisherman.

### **What does it cost?**

The cost for production of this card is £10.00\*.

### **How do I apply?**

- 1) You must complete and sign the application form overleaf.
- 2) You must submit 1 passport-size photograph signed by you on the reverse. It must be attached either by staple or paper clip in the box at the top left-hand corner of the application form. Your photograph will be printed on your card.
- 3) You must provide the dates on which you completed the required courses. These will be checked and verified on our database. If you have lost or misplaced your certificates and can't remember when you completed the courses, please call us on the number below before returning this application form and we will help you.
- 4) If any of your courses were not Seafish courses (e.g., STCW or RYA), you must send us scanned copies of your certificates, so that we can check and verify them.
- 5) Send your completed form, with photograph and payment\* to the address below.
- 6) Your card will be posted to the address provided by you on your application form. Please allow up to 28 days for production and delivery.

**\*You can pay over the phone with a debit/credit card by calling the Training Administrator (see number below). Alternatively you can pay by cheque or postal order made payable to Sea Fish Industry Authority. Please do not send cash.**

Congratulations on having completed your four basic mandatory courses listed above.

Once you have gained more than 6 months of fishing experience the next step on your career path is to book onto the Seafish 1 day Safety Awareness course. This course uses the knowledge you have gained during your six months at sea and looks at risk assessment as a way to further reduce possible accidents at sea. Risk Assessments are usually carried out by crew members who have a good knowledge of on- board operations and processes.

If you wish to remain a commercial fisherman this course **must** be completed within two years of having completed the Health and Safety course.

- with the owner, managing agent and/or skipper of the vessel you are working on, or wanting to work on (to confirm to them what training you have completed).
