# Existing WSR programmes:

## **UK Fishing**

#### A growing industry

- Increasing number of migrant fishers in UK vessels.
- Nationalities: Philippines, Ghana, and Indonesia with fewer numbers from Latvia, Lithuania, Romania, Poland, India, and Sri Lanka.


#### 2021 survey:

OCUS ON

- 'In transit' visas: 12 nautical miles away, no legal authority to "enter" the UK when in port → forced to live onboard the vessels (multiple dependencies).
- 18% forced to work on a vessel not named in their contract.
- Working excessive hours.
- Earnings from £400 to £1,500 per month (few on catch-based cash bonuses).
- Average amount of debt in recruitment was £2000.
- 35% reported experiencing regular physical violence

# Phase 1: planning (completed)

- Partnership:
  - International Transport Federation
  - Coalition of Immokalee Workers
  - Fair Food Standards Council
  - TUFTs University, Dr. Jess Sparks
- Phase 1 outcomes:
  - First draft Code of Conduct
  - Blueprint for the implementation of a WSR programme in UK fishing
  - Identified region and two ports in North East Scotland
  - Dialogue with retailers and vessel owners



## Phase 2: implementation

- Partnership:
  - International Transport Federation
  - Focus on Labour Exploitation
  - Coalition of Immokalee Workers
  - Fair Food Standards Council
  - TUFTs University, Dr. Jess Sparks
- Other key stakeholders:
  - Scottish With Fish Producers Association (SWFPA)
  - Retailers and other buyers
  - Industry groups and networks
  - Local networks supporting migrant fishers



## Next steps

- 1. Conduct outreach to migrant fishers in NE Scotland
  - Finalise Code of Conduct
  - Complaint mechanism and audit protocols
  - Worker-to-Worker educational component
- 2. Standards Council for fishing as an independent legal entity
- 3. Work with industry to consult and sense-check outputs with industry
